Committee recommends continuation of affiliation till the completion of research work of the existing research scholars.
- 2) For Sociology and Geography subjects college has appointed faculty members on clock Basis (CHB) and they are having Ph.D. Considering paucity of research centers and research recognized supervisors, committee is of opinion that faculty members appointed on Clock Hour Basis (CHB) are considered for granting of continuation of recognition for research centers in these two subjects Sociology and Geography.


